

Re: **Notice of Missed Interview for Applications Pending > 30 Days and for Closed Recertifications**

Overview

The Notice of Missed Interview (NOMI) is mailed to clients who miss an application or recertification interview for SNAP. Currently, case managers cannot generate a NOMI to a client who is the grantee of a case that has been pending for more than 30 days or to a client who is the grantee of a closed case.

Effective with BEACON Build 44.9, case managers will have the ability to generate a NOMI to an applicant whose case has been pending for more than 30 days and to certain closed cases.

The use of this enhanced NOMI functionality will be infrequent but its availability is critical for maintaining accurate electronic case records.

Generating a NOMI

Applications Pending for More than 30 Days

BEACON is now programmed to generate a NOMI for pending applications up until day 50.

Closed SNAP Recertification or Interim Report (IR)

BEACON is now programmed to generate a NOMI for closed cases that have been closed within the last 30 days for one of the following reasons:

1. Your certification period has ended;
 2. Failure to submit the required verification;

3. Initiated but failed to recertify;
4. Failure to complete an Interim Report; and
5. Failure to provide required Interim Report verifications.

In addition to generating a NOMI from the Letter Request page, the NOMI icon on the Pending Application/Reinstatement view, the Reevaluations Due view, the Reevaluations Due – Interim Report view, or through the electronic case folder using the Document, Appointment Letter & EBT tab, case managers will now be able to generate a NOMI from the Closed/Denied within last two Months view.

**Change to
NOMI Language**

Minimal changes were made to the language of both the Application and the Recertification NOMIs to improve overall readability and to clarify instructions to the client.

BEACON will generate the appropriate application NOMI based on the number of days the application has been pending. BEACON will generate the recertification NOMI based on whether or not the case being recertified is active or closed.

Attachment A is a sample of the NOMI for applications pending for more than 30 days and Attachment B is a sample of the NOMI for closed recertifications.
